1. Effective Date

a. This is to be shown as:

(1) For Starts – as the first of the month and year following the date on which the form was signed.

(2) For Stops – as the first of the month and year from and including which no further deductions are to be made: e.g. a stop effective from 01 Aug 07 means that the final deduction for subscriptions would be for the month of Jul 07. This must be a date after the form is signed.

2. Subscriptions will be deducted monthly in arrears at 1/12<sup>th</sup> of the annual percentage of a day's gross pay as notified by the administrators of the fund. Percentage subscriptions will be based on the rate of pay recorded as in issue at the time the deduction is made.

3. When there is a variation the type of subscription required (e.g. on transfer to a new Regt/Corps), one form is required to stop the current subscription and another form is required to start the new subscription.

4. To ensure that a subscription is started or stopped from the month indicated at Part 2, this form must be received by the Regimental Secretary not later than the **First** day of that month.
